<input type="checkbox"/>	Divorce Decree(s) or Death Certificate(s)	<input type="checkbox"/> Provide a divorce decree (absolute or final) or death certificate issued by a public authority to show that a public record exists of the termination of all prior marriage(s). Provide all pages of the decree including the judge's signature.
<input type="checkbox"/>	Record of Name Change	<input type="checkbox"/> If either you or the person you are filing for has used a name other than that shown on the relevant documents, you must provide legal documents that effected the change. e.g., marriage certificate, adoption decree, court order or deed poll.
<input type="checkbox"/>	Beneficiary's foreign passport photo page	<input type="checkbox"/> Provide a photocopy of the beneficiary's valid foreign passport photo page.
